12th Meeting of the National Skills Qualifications Committee (NSQC)

The 12th meeting of the National Skills Qualifications Committee (NSQC) was held on 21.07.2016 in New Delhi. Mr. S. Ramadorai, Chairman, NSDA chaired the meeting.

Agenda Item No. 1: Approval of Minutes of the 11th Meeting of NSQC

There were no further comments on the minutes of the 11th NSQC meeting and the same were treated as approved. The action taken report on all the agenda items is enclosed.

Agenda Item No. 2: NSDA's update on NSQF related activities

2.1 National Quality Assurance Framework (NQAF)

DG, NSDA informed the NSQC that under the Quality Assurance Framework, the first manual, i.e. the Overview Manual was approved by the 10th NSQC. The three manuals namely registration of NSQF qualifications, accreditation of training/education institutions and accreditation of assessment bodies were tabled before NSQC for approval. A brief presentation was made by consultant, NSDA on all the three manuals. The three manuals were approved by the NSQC. Further, DG, NSDA mentioned that the drafts of all the remaining 4 Manuals have been completed and the same would be tabled before NSQC by September 2016. (Action: NSDA)

2.2 NSQF Roll Out and Capacity Building of States and Ministries

DG, NSDA informed the Committee about the various skill development initiatives undertaken by NSDA in the states and with the central ministries. The Committee noted the same.

2.3 Recognition of Prior Learning (RPL)

DG, NSDA informed that NSDA has submitted the draft RPL Policy to MSDE. The Committee noted the same.

2.4 Consultations held with industry representatives on the industrial validation process of the qualification files.

DG, NSDA stated that consultations with industry representatives across seven sectors for vetting the industrial validation process of Sector Skill Councils (as an action w.r.t Minutes

under Agenda Item 2.3.1 of Minutes of 9th NSQC) have been conducted by NSDA. DG, NSDA mentioned that it was revealed through the above consultations that;

- a. There was limited industry consultations while developing qualifications
- b. Assessments should be undertaken by industry experts instead of consultants not having industry expertise

It was agreed that NSDA would be undertaking a study on industry linkages to analyze the status of NSQC approved qualifications till date. COO, NSDC suggested that SSCs could assist NSDA in conducting consultations with industry representatives on industrial validation process. In this regard, the Chairman, NSDA emphasized that feedback of third party validation needs to be taken positively for bringing overall improvement in the system. (Action: NSDA)

2.5 Proposal for setting up of three new SSCs

DG, NSDA informed that with regard to the issue on recommendations given by NSQC for setting up of three newly formed SSCs namely Chemicals and Petrochemicals SSCs, Green Jobs SSCs and Paints and Coatings SSCs, the specific conditions which was to be fulfilled by the respective SSCs have been addressed. However, regarding the fulfillment of general condition, NSDC updated that they have submitted the funding matrix of each SSC. NSDC was asked to submit a decision support matrix justifying need for formation of SSC with clear recommendations for each SSC and the same is still awaited. (Action: NSDC)

2.6 Development of Qualifications Register

DG, NSDA informed NSQC that a National Qualifications Register which is the repository of all approved qualifications with their corresponding NSQF levels has been developed by NSDA. The register comprises of 1520 NSQC approved qualifications, which is online for public viewing at www.nqr.gov.in. The Committee noted the same.

Agenda Item No. 3: Consideration of Qualification Files (QFs) for approval

3.1 A total of 124 Q Files were tabled before NSQC for approval, out of which 33 QFs were submitted by three SSCs and 91 QFs were submitted by four ministries which were approved by the NSQC. **Details of these Qualifications are at Annexure II**. The sector wise list of QFs approved by NSQC is as under;

- 3.2 In this regard, NSDC observed that some of the job roles are common across qualifications tabled by SSCs and ministries. It was requested by them that if ministries have done any comparison then the same may be shared with NSDC. Alternatively, NSDC could undertake comparison with the ministry approved qualifications. (Action: NSDC)
- 3.3 In case of some of the unique qualifications being presented by ministries, COO, NSDC also added that NSDC would like to embrace some of the unique qualifications developed by the various ministries. In particular Ministry of MSME (such as Fragnance and flavours, ball making) for PMKVY trainings could be useful. (Action: NSDC)

Agenda Item No. 4: Any other matter with the approval of the Chair

DG, NSDA informed NSQC that in order to seek NSQC approval some of the key criteria have to be followed by all the submitting bodies as given under;

- a. Submitting bodies have to submit the course content for every Qualification for seeking NSQC approval.
- b. With regard to qualifications approved in 12th NSQC, SSCs need to submit the course content within next three months.
- c. Similarly, SSCs need to submit the course content for all the previously approved qualifications within this financial year.
- d. NSDC need to share the status report on the actively utilized NSQC approved qualifications. The course content for such qualifications needs to be submitted by December 2016.

In his closing remarks, Chairman, NSDA made certain observations pertaining to the NSQC approval which is as given below;

a. Convergence of efforts is the ultimate goal. The focus should be on employment generation no matter which body is submitting the qualifications.

- b. Employers involvement in the development of qualifications is important and to ensure the same, NSDA would be conducting verifications and consultations with industry representatives.
- c. In order to address the scale of problem, all the stakeholders should work in collaboration and collective learning is very crucial.
- d. We need to learn from French example where ultimate measure of the qualifications is done by actual deployment on ground.
