B OR C Level Answer Script**

1. There is no provision for Re-checking, Re-evaluation, Re-totaling, or Disclosure of **O Level (M1-R5.1 to M4-R5.1)** and **A Level (A1-R5.1 to A4-R5.1)** Online Examinations. **If candidate still pays the fees for these services, then fee paid will not be refunded or adjusted under any circumstances.**
2. Applications for re-totaling of answer scripts can be submitted **within 10 (ten) days from the date of result publication. Applications received after this period will not be entertained.**
3. **Applications submitted after the prescribed deadline will be summarily rejected or returned to the applicant. No further communication in this regard will be entertained.**
4. Applications **submitted by anyone other than the candidate will be outrightly rejected by NIELIT.** No correspondence / Grievance / RTI will be entertained in such cases.
